# **Coordinated Assessment/Ending Homelessness Committee**

Bob spoke about the upcoming presentation in June for the Coordinated Access (CA). He discussed some key points that he would like in the presentation, such as some successes, changes, data, coverage, etc. Bob spoke about the need for assigned days and assigned back-up. All agreed to implement assigned back-up for each agency's Coordinated Access phone day.

Peter mentioned the possibility of having the homeless school outreach worker handling the Coordinated Access line for HHI.

Bob spoke about the significant need for coverage at the CA line. He would like to try to elaborate a plan for a successful transition into CA intake and collaborative effort of the agencies that are part of the CA team. He reminded everyone of the need to resolve CA because HUD' requirements and would like to find a way to get other agencies to cover CA.

Peter said that the Coordinated Access could be very beneficial and that there's a lot of potential to improve access, appropriate diversion, and maximize use of technology. If it doesn't, craft a plan, a longer term plan that would change those outcomes.

Dawn mentioned that she is seeing more females with addiction at Bridges.
