# Committee on Ending Homelessness Meeting Minutes of the December 1, 2004

<u>Present at the meeting were:</u> Eileen Brady, Maria Brown, Lisa Christie, Bill Gray, Linda Jeynes, Donna Juszkiewicz, Peter Kelleher, Bob Mack, Germano Martins, Laura Nault, Klaas Nijhuis, and Miles Pendry.

- K. Nijhuis called the meeting to order at 9:10 am. The minutes from the November 3<sup>rd</sup> meeting were reviewed; P. Kelleher motioned to accept minutes as written, M. Brown seconded and the motion carried.
- M. Pendry announced that the logic model (handout) for the super NOFA was now on the CoC website for everyone to see. K. Nijhuis felt this would be a good tool to use in monitoring our progress with the plan elements.
- K. Nijhuis than led a discussion about the implementation of the Executable Plan Elements of the Plan to End Homelessness. He made the suggestion that one person be made the contact person for the GNCOC to collect newly implemented project information and report progress as relates to the Ending Homeless Plan. A discussion followed about how this same information needs to be a regular item on the GNCOC agenda so the minutes will reflect the progress on implementation of the plan each month. K. Nijhuis recorded the committee's suggestions about what we have done to date, what we a doing now, and what needs to be done on flip charts. (Copy attached herewith) B. Mack agreed to contact Maggie Decker about being the contact person for collecting information.
- P. Kelleher announced that the public notice "Leaving a Light on" has been revised and will be sent to the press soon. E. Brady will be talking to the Telegraph reporter about future articles to promote GNCOC and encourage participation on ending homelessness in the greater Nashua area.
- E. Brady handed out a draft copy of a letter to be sent to elected officials to interest them in helping to end homelessness. The committee reviewed the letter and offered suggestions. E. Brady will revise the letter and send out from this committee. L. Jeynes will research the minutes to be sure this responsibility was approved by the GNCOC.

(From the May, 2004 meeting minutes of the GNCOC: "M. Brown motioned that the Ending Homelessness Committee be allowed to continue to compose the final draft of the plan to end homelessness, to coordinate arrangements to publicly present the plan, and to be the lead entity in publicly promoting the Good Neighbor Agreements and monitoring their receipt and compliance. W. Furnari seconded the motion and the motion carried".)

- B. Mack reported that he and his committee would revisit the "pledge card" idea and have a proposal ready for the February meeting of this committee.
- E. Brady reported that 60 people signed on in support of ending homelessness in the greater Nashua area at the Nashua Stroll on November 27<sup>th</sup>.
